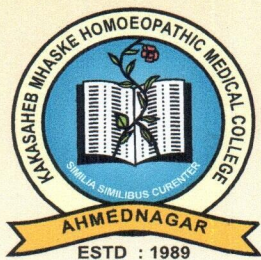

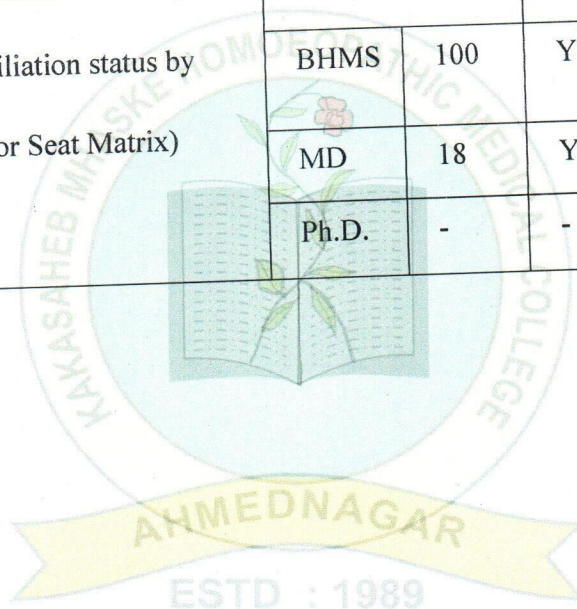

- The admission shall be done only through the Competent Authorities.

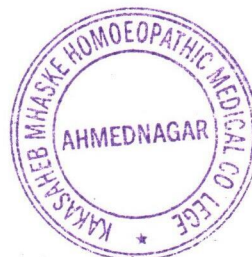
